➤➤➤ ANDION ZOOM

It's been three weeks since the Andion Zoom Town Hall meeting. Andion refused to host an in person Town Hall for the community; therefore the Clean Air Alliance respectfully participated in their Zoom format with a huge turn out of 500 participants (from start of Zoom). CAA presented questions during the Q&A period at White Rock Council on Monday, Nov 27th. We expect to attend White Rock with a delegation on Dec 11th.

In our question and answer period with White Rock, Mayor Knight indicated she would table the concerns from the community with respect to a decision on the air quality permit prior to an Impact Assessment Review being completed by the Federal Government of Canada.
